## National Veterans Memorial and Museum Names Members to New Foundation and Operating Boards

**COLUMBUS, Ohio** -- The National Veterans Memorial and Museum held its first board meetings where national and community leaders were named to new foundation and operating boards. Both boards are chaired by Lewis "Lou" Von Thaer, President and CEO of Battelle.

The board meetings marked the official transfer of museum operations from the Columbus Downtown Development Corporation to independent boards of directors. In response to COVID-19, each board meeting was held virtually on March 31, 2020.

The Columbus Downtown Development Corporation constructed and opened the National Veterans Memorial and Museum to the public in October 2018. The museum, nationally designated by Congress and signed into law by the President in June 2018, is dedicated to telling the stories of service men and women, from all military branches and during peacetime and war.

"We are thankful for the commitment these leaders are making to support our mission and ensuring, through their guidance, that we continue our path of supporting Veterans and impacting lives. Their leadership is especially critical during this unprecedented time," said Lt. General Michael Ferriter, U.S. Army (Retired), President and CEO of the National Veterans Memorial and Museum.

In addition to the two boards, a Veterans Advisory Committee composed of Veterans representing all branches of service will be providing advice and guidance on the direction of programming. This committee is chaired by Major General Dennis Laich, U.S. Army Reserves (Retired).

"On behalf of Veterans across the nation, we are forever grateful to the Columbus Downtown Development Corporation, under the leadership of CEO and President Guy Worley, for building a magnificent facility and guiding us to this point in time," Ferriter added.
